Non-Winners of a Sweepstakes at One Mile or Over allowed 2 lbs. Non-Winners of A race other than Claiming or Starter at One Mile or Over allowed 4 lbs. Maidens 6 lbs. High weights preferred, Stakes winners second preference and third preference to Stakes placed horses.
