





Rodeo Drive Stakes Breeders' Cup "Win and You're In" Challenge Race \$200,000 Guaranteed

(Grade II)

FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD By subscription of \$100 each if made on or before Friday, September 20, 2024 or by Supplementary nomination of \$4,000 due at time of entry. All horses to pay \$1,500 to enter and an additional \$1,500 to start with \$200,000 guaranteed, of which \$120,000 to first, \$40,000 to second, \$24,000 to third, \$12,000 to fourth and \$4,000 to fifth. Three-Year-Olds 122 lbs. Older 126 lbs. Non-Winners of a Grade I or Grade II Stake at One Mile or Over since April 5, 2024 allowed 2 lbs. Non-Winners of a Graded Stake at One Mile or Over since October 5, 2023 allowed 4 lbs. The Rodeo Drive Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Rodeo Drive Stakes will be entitled to automatic entry into the 2024 running of the Breeders' Cup Filly & Mare Turf division. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2024 Breeders' Cup Filly & Mare Turf or will receive a credit equal to the Breeders' Cup Filly & Mare Turf pre-entry and entry fee amount towards any other 2024 Breeders' Cup Championship race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2024 Breeders' Cup World Championships held at Del Mar on November 1 and 2, 2024, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 21, 2024. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championships races are to be run Lasix Free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated Lasix Free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out-of-competition testing by HIWU on behalf of HISA (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend, or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program. Starters to be named through the entry box by closing time of entries. A trophy will be presented to the winning owner.
